### **Introductory session**

With over 668,445 post offices, 5.3 million staff and physical infrastructure covering 192 countries, the postal sector represents one of the largest physical networks in the world. As a specialized agency of the United Nations System, the UPU has a unique role to play in supporting the socio-economic benefits of the postal sector. Through the Istanbul World Postal Strategy, its roadmap for the 2017–2020 period, it has already achieved far-reaching impact in all regions.

But as the next four-year strategic cycle approaches, it is time for the UPU to develop the future Abidjan Postal Strategy for 2021-2024, with the ultimate aim of enabling the growth of the UPU, and thus, of the postal sector. Underpinning this new strategy, Postal Vision 2030 will be the UPU's advocacy message for the sector. It should inspire all stakeholders to take action in their respective fields of competence and it should be supported by the strategic pillars that will compose the Abidjan Postal Strategy.

This introductory section will provide an update on the global and regional trends affecting the sector, the implementation of the Istanbul World Postal Strategy, and the development of the UPU's future strategy.

### **Regional perspectives: Governments**
