

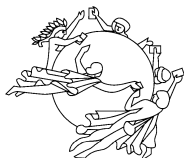

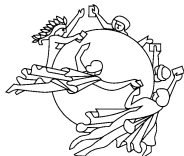

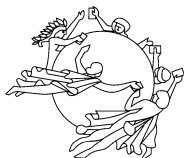

1.	Q		Do you have any indication on the volume of services or people required for this contract?
	A		As defined in the tender under section 4.2: Bidder requirements: Bidders are expected to offer its pricing structure based on daily rates, on working packages of 100 person days each, 500 person days each, 1000 person days each and for the complete potential project volume of 6000 person days
2.	Q		Do you expect the work to be performed only on site? Are off-site and teleworking modes accepted?
	A		We expect the work to be done both offsite and onsite. Major part of the work will potentially need to be done offsite. Yes, teleworking mode is acceptable under the prevailing Covid19 conditions to be in compliance with local government rules and regulations is acceptable
3.	Q		In relation to the following sentence “The bidder has to have its headquarters or at least a branch of its company in Switzerland” – Could you please clarify: <ul style="list-style-type: none"> • In case of a joint venture between two companies is it acceptable that one of the company has a branch in Switzerland? • In case of a branch in Switzerland we understand that this entity should participate as subcontractor or partner in the offer. Could you please confirm? • In case of subcontracting, we understand that subcontractors have not necessarily to be established in Switzerland. Could you please confirm?



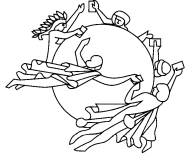
	A	It is acceptable. If in case of JV, one of the companies has a branch at Switzerland The entity based in Switzerland should be the party bidding for the contract (as a partner). Refer to sec. 2.6 of the call for tender.
4.	Q	Has this tender been awarded previously or is this the first time this tender is being awarded? <ul style="list-style-type: none"> If it has been awarded previously is there any information you can share?
	A	This is a new tender and will be awarded for the first time.
5.	Q	Is there a standard or preferred pricing structure? <ul style="list-style-type: none"> For example average rate per position?
	A	We are requesting daily rates (hourly rates) for consultants matching the skills and service requirements.
6.	Q	Under the terms of the call for tenders, the vendor is expected to provide services in Business Analysis, Software Development and Quality Assurance. Could you give us an idea about the provisional proportion for each service category in terms of person days and on an annual basis? More importantly, what is the proportion of .Net versus Java development for the software development category?
	A	The max requirement will be of software developers. In the following descending order of person days <ul style="list-style-type: none"> Software Developers Quality Assurance (Software testers) Business Analysts
7.	Q	Section [4.3: Consultant requirements] stipulates that « The bidder has to have its headquarters or at least a branch of its company in Switzerland. » Can a non-Swiss located company participate and be eligible for this call for tenders with a commitment to establish itself in Switzerland in a second phase?
	A	No
8.	Q	Could you disclose the other locations for onsite assignments if any other than Weltpoststrasse in Bern?



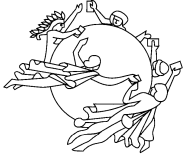
	A	The onsite location will be at Bern. It is possible that the consultant may be send on mission (business trip) to work at customer site.
9.	Q	Would UPU consider nearshore locations (CET-CEST +/- 2h) as an opportunity?
	A	Yes. The offsite locations as defined in the RFP will be the nearshore locations (CET-CEST +/- 2h). It is part of our assessment criteria.
10.	Q	Would offsite staff be called onsite, what is the expected lead time for the staff to reach UPU premises (1 day, 1 week, other), what is the expected duration for their stay onsite (1 day, 1 week, other)?
	A	Yes. Offsite may be called onsite if project demands so. The expected lead time for the staff to reach UPU premises will typically be 1 day and the duration will depend on the work to be accomplished. Typically, it may range from one week to a month
11.	Q	Consultant experience is usually defined by xxxgroup as Junior (<5y), Experienced (<10y) and Senior (+10y), are these definition acceptable to UPU for this Tender?
	A	Relevant experience of at least 5 years for Junior role and more than 5 years for Senior role. UPU technical team may further corroborate the experience mentioned on consultant's CV on the basis of technical evaluation.
12.	Q	Could you please specify the following regarding the staff that should be dedicated to the project? It is stated that two members of staff should be located in Berne but will mostly work remotely. Can we propose a fully remote team but that will work in the same time zone as Berne? So, is it okay not to have two onsite specialists but to have a team in other locations in the UN?
	A	The mix of offsite and onsite will depend on the kind of the project and specific operational needs. It is very much possible to have the full development team working remotely at an offsite location.
13.	Q	Can a Malaysian company participate in this tender?
	A	Yes, but with a local presence (branch office or a subsidiary) in Switzerland
14.	Q	Section 2.19, page 9: It is stated that: "The UPU is not bound to accept the lowest tender and reserves the right to accept all or part of a tender." How would you split the services? Could you please confirm if this Long Term Agreement (LTA) is to be awarded to a solely vendor? Or is it an homologation of various vendors (multi-awarding)?



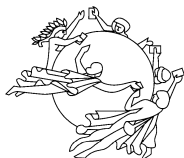
	A	The contract is for a fixed period of 4 years and it could be awarded to a single or multiple vendors; approved by the Director general on the recommendations made by the Tenders and Procurements Committee
15.	Q	Section 4.2, page 13: Which is the profile you might require to be on-site for us to provide the most suitable CVs?
	A	As described in Section 4: Service requirements. Same profile requirements for onsite and offsite resources.
16.	Q	Section 4.2, page 13 The 2 onsite profiles are to be based in a regular basis in UPU Headquarters at Berne?
	A	Yes, that is correct
17.	Q	Section 4.2, page 13 Are the 2 on-site profiles introduced to the offer binding to the project delivery? Or can they be replaced by equivalent profiles in the event they are not available at the award time?
	A	The profiles are not binding and can be replaced by equivalent profiles
18.	Q	Section 4.4, page 14 One of the key evaluation criteria is the location and accessibility of the company. Could you please list your preferred time zones for the project delivery?
	A	For offsite: nearshore locations, preferably with time zone difference of CET-CEST +/- 2h
19.	Q	Sections 4.3 and 4.6, pages 14/15 Could please clarify where the resources will be located? In section 4,3, UPU requires 2 onsite and 4 offsite consultants but in section 4,6, UPU defines the location mainly from its own premises at the offsite location and just from time to time the tasks will be carried out at UPU headquarters. It seems contradictory. The objective is to clarify the from where UPU is expecting the resources because it is unclear.
	A	The resources will be located either onsite at UPU Bern or offsite at nearshore locations. However, the ratio of offsite to onsite in the projects is estimated to be higher. Section 4.3, requires the bidders to provide CVs of 2 onsite and 4 offsite consultants
20.	Q	Section 4.3, page 14 Could you please clarify how many CVs are you expecting? 6 in total (covering the 3 profiles of consultants)? Which profiles do you want onsite and which ones offsite?



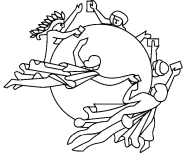
	A	2 on-site consultants and 4 off-site consultants for each profile Therefore Onsite: 1 Junior + 1 Senior Developer Analyst, 1 Junior + 1 Senior Developer, 1 Junior + 1 QA analyst (Software Tester) Offsite: 2 Junior + 2 Senior Developer Analyst, 2 Junior + 2 Senior Developer, 2 Junior + 2 Senior QA analyst (Software Tester)
21.	Q	Could you please provide locations details for the sites support?
	A	The onsite location is: Weltpoststrasse 4, Bern Bern 3015
22.	Q	What peripherals should we use for service delivery (laptops, mobiles, etc.)?
	A	The IT infrastructure and development platform to be used for delivery of the services will be in compliance with UPU's software development practices – we have it documented for our partners”
23.	Q	Is it possible to use resources in English and Arabic? Or just in English?
	A	Full proficiency in English language is required. Knowledge of other languages, especially those used in the United Nations system, is an advantage
24.	Q	Could you please clarify the “Responsibility for the source code developed”?
	A	The developer will be responsible to make corrections or changes to his or her authored source code.
25.	Q	Is there any specific technology preference for software development?
	A	UPU mostly uses Microsoft® tools and technologies and will be the preferred choice where applicable
26.	Q	Should the solutions be available in premises, cloud, or both?
	A	On-premise.
27.	Q	Should the software be available in Arabic language in addition to the English?



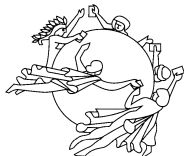
	A	In English and as and when required in other languages especially those used in the United Nations system
28.	Q	Should the solutions be limited for software development and hardware support outlined in the scope of work?
	A	The services being requested will be largely limited to those related to the different phases of a Software development Life Cycle (SDLC)
29.	Q	Should the hardware development support be available from day one?
	A	Question being asked is not clear to us.
30.	Q	In par. 4.4 you say that the criteria “Competence and experience of the consultants” can be awarded a maximum of 20 points but you do not specify how you will evaluate it. For example, if we provide two consultants per role, one Senior and one Junior, the Junior may not have all the characteristics you ask (being a junior...): will the Junior profile lower the overall score for that part? Do you expect the Junior profile to meet all the characteristics or is there some characteristic which is more important to have for them?
	A	The maximum of 20 points for the “Competence and experience of the consultants” will be awarded based on equal number of senior or junior profiles furnished by the bidder
31.	Q	The references must be signed by the clients or is it sufficient to provide the client’s contact (name, email, phone) to provide eventual confirmation of our declarations?
		Providing references are enough and signatures are not necessary.
	A	
32.	Q	Could you disclose the other locations for onsite assignments if any other than Weltpoststrasse in Bern ?
	A	The onsite location will primarily be the IB premises at Bern (4 Weltpoststrasse)
33.	Q	Would UPU consider nearshore locations (CET-CEST +/- 2h) as an opportunity ?
	A	Yes.
34.	Q	Would offsite staff be called onsite, what is the expected lead time for the staff to reach UPU premises (1 day, 1 week, other), what is the expected duration for their stay onsite (1 day, 1 week, other) ?



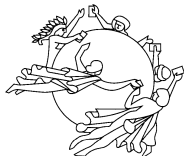

	A	The documents can be digitally signed.
37.	Q	With reference to paragraph 4.1. ("The VENDOR will be expected to..."), do the requirements listed in the relevant sub-paragraphs have to be fulfilled by the company's team of developers as a whole or do all the requirements have to be fulfilled by each consultant whose CV is submitted in the tender?
	A	Both
38.	Q	With reference to paragraph 4.8., does the sentence "Any other costs to be incurred by the Vendor, including any travel and subsistence costs incurred in the provision of the services at locations other than its own premises and specifically designated by the UPU, shall be subject to the prior written consent of the UPU. " mean that there is provision for reimbursement by the UPU of travel expenses when consultants are required to be present at the UPU's premises?
	A	Here the reference is concerning the consultant, onsite or offsite when required for project work.to any travel to locations other than his defined work location
39.	Q	"XXXXX" is a subsidiary company of "XXXXX" in Switzerland and "XXXXX", India. We wanted to check whether this is acceptable in the framework of this tender.
	A	Yes it is acceptable.
40.	Q	"XXXXX" is recently registered in Switzerland but its holding companies have more than a decade experience in building similar software products and platforms for enterprises across many countries. We would like to share those references and accomplishments as part of our RFP responses. Please confirm these will be accepted.



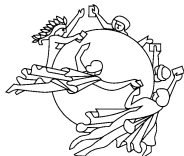

	A	Yes, it is acceptable and considered as an added advantage.
43.	Q	Is the minimum number of consultant CV's six (6), meaning 2 on-site consultants and 4 off-site consultants, as per section 4.3? Is there any minimum in regards to the skill sets (business analyst, software developer, software tester)?

44.	Q	Is knowledge of the RANOREX test automation tool an absolute must have?
	A	UPU uses RANOREX automation tool, so consultants with knowledge of this tool is a mandatory requirement.
