#### Pascal Clivaz

Deputy Director General, Universal Postal Union

Mr. Clivaz is Deputy Director General of the UPU's International Bureau since 1 January 2013. Until his election, he was Director of finance and strategic planning at the International Bureau, which he joined in 2005. A law graduate, Mr. Clivaz has held numerous roles in both private and public organizations, as well as at the European Commission in Brussels. Mr. Clivaz has 17 years' experience working in the postal sector and the UPU, having begun his postal career at Swiss Post as a scientific advisor responsible for finance and strategy, before rising to become director of international affairs and a member of the Swiss operator's management team. At 44 the year of his election, he is one of the youngest top executives in the history of the Union.



## Annemarie Gardshol Group CEO and President, PostNord

Born in 1967, Ms. Gardshol has been a Member of the Group Executive Team since 2012 and of the Group Leadership Team since July 1, 2019. She is also a Board member of SCA AB and Essity AB. Previously, she held the positions of the Head of e-Commerce & Corporate Clients in PostNord, Chief Strategy Officer (CSO), executive positions at Gambro, and the position of management consultant at McKinsey & Company. Ms. Gardshol holds a Master of Science degree in Industrial Engineering.



David McRedmond CEO, An Post

Mr. McRedmond was appointed Chief Executive Officer of An Post in October 2016. He has led the company's transformation programme and is personally driving An Post's Sustainability Charter. Mr. McRedmond was previously CEO of TV3, Commercial Director of Eircom and Managing Director of Eircom Enterprises. During his early career as a retail industry executive in the UK and USA, he held roles such as Operations Director of Waterstones and CEO of WH Smith Inc. Mr. McRedmond was appointed chairman of Eir in 2018; he is a director of Premier Lotteries Ireland (the National Lottery) and a fellow of the Royal Society of Arts. A native of Dublin, he holds a Master's Degree in Modern Irish History from University College Dublin.



## Þórhildur Ólöf Helgadóttir

Managing Director and CEO, Iceland Post

Ms. Helgadóttir accepted the post of Managing Director and CEO in December 2020. Before that she held the position of Iceland Post's Chief Financial Officer (CFO) since August 2019. She has extensive experience in the field of finance and operations and was employed as CFO of 66°North for the past two years. Before accepting the posting at 66°North, she was CFO of the car dealership Hekla from 2014 to 2017; and prior to that, the CFO of Securitas and a project manager for Deloitte. She was a member of the Board of Directors of Sjóvá Almennar for a number of years and sat on the boards of the subsidiaries of 66°North and Hekla. Ms. Helgadóttir holds a cand. oecon. degree from the University of Iceland.

Mr. Walsh became Chief Executive of NZ Post Group in May 2017. He joined the Group in February 2015 as Chief Financial Officer having previously held the position of General Manager Corporate and Finance at KiwiRail.
