Reference: 3100(DIRCAB)1129 Subject: Invitation to the Council of Administration (CA) and Postal Operations Council (POC) sessions (22–26 November 2021)

Dear Sir/Madam,

On behalf of the Chair of the Council of Administration and the Chair of the Postal Operations Council, I wish to invite the members of the CA and the POC and observers to attend the regular 2021.2 CA and POC sessions (S0). The meetings are to be held at the UPU International Bureau (IB) in Berne from 22 to 24 November 2021 (POC) and from 25 to 26 November 2021 (CA), each day from 12.00 to 16.00 CEST (UTC+1). In the week before the CA/POC sessions, there will be meetings of the EMS General Assembly on 18 and 19 November 2021. The CA Management Committee and the POC Management Committee meetings are to be held on 19 November from 12.00 to 14.00 CEST (UTC+1) and on 22 November 2021 from 10.00 to 11.30 CEST (UTC+1), respectively. The timetable and the provisional agendas and meeting documents for the CA and POC will be available on the UPU website at www.upu.int/en/Members-Centre.

It should be noted that, owing to the COVID-19 pandemic, a number of CA/POC members and observers face difficulties in sending their representatives in person to this session. As a result, the CA and POC S0 will be a hybrid method of attendance, namely, attendance on site where possible, with remote participation for delegates unable to attend the session in person because of the COVID-19 pandemic; accordingly, as set out in Annexes 1 and 2, a number of provisions of the CA and POC Rules of Procedure will be amended and/or suspended to allow for remote participation.

i Physical participation

As a result of the ongoing COVID-19 pandemic, on 20 September 2021, the Government of Switzerland published new rules for entry to Switzerland and for people vaccinated abroad to access the COVID certificate that may be applicable to travellers from abroad, which, under certain conditions, will permit the physical attendance of delegates of members countries at the CA and POC sessions. Information in this regard can be found on the Swiss Federal Office of Public Health website at www.bag.admin.ch/bag/en/home.html. Delegates planning to attend in person should pay careful attention to these requirements for their entry and stay in Switzerland.

ii Registration of participants

All delegates from CA and POC members and observers attending the session in person/or remotely are required to register through the UPU's Event Management Platform (EMP). Technical details relating to remote participation and registration instructions will be forwarded in a separate circular letter.

iii Voting

CA and POC members will authorize their delegates to vote in accordance with the CA and POC Rules of Procedure. In the case of open ballots, all CA/POC members participating either remotely or physically will be entitled to participate using the UPU's online electronic voting platform.

In the case of a secret ballot, only CA/POC members physically present will be entitled to participate in such a ballot using electronic voting devices or traditional paper ballots. However, a CA/POC member participating remotely will be entitled to delegate its right to vote to the representative of another member of the CA/POC physically present in Berne, provided that it gives notice (either in writing or orally at the meeting) to the CA/POC Chair prior to the vote.

iv Submission by UPU member countries of questions to be discussed at CA and POC sessions

Pursuant to articles 14.3.2 of the CA Rules of Procedure and 15.3.2 of the POC Rules of Procedure, any UPU member country wishing to submit questions for discussion at this CA/POC session is required to send the relevant documents to the Secretary General at least six weeks before the opening of the session (8 October 2021 for the POC and 13 October 2021 for the CA).
