## **General conditions of sale for the public**

### **Ordering publications**

The UPU's publications can be ordered using this form, by specifying the chosen publication, number of copies and required languages, in addition to the form of payment.

When paying by credit card, the order must be sent by fax.

Ordered publications are dispatched as soon as payment is received.

For publications which appear regularly, you can place a standing order which will be invoiced automatically. The rate indicated for the *Union Postale* magazine includes the subscription for the full calendar year (four quarterly editions).

### **Rates**

The rates in this list are subject to change without prior notice. They are exempt from value-added tax (VAT).

The rates are net and in Swiss francs (CHF). Payment must be made in Swiss francs.

The UPU does not give discounts to publishers or other institutions.

### **Return of publications**

Publications can be returned only if there has been a delivery error.

### **Applicable law**

The substantive law applicable is Swiss law.

### **Settlement of disputes**

Parties will endeavour to find an amicable solution to all order-related disputes.

Settlement of disputes through conciliation is subject to the Conciliation Rules of the United Nations Commission on International Trade Law (UNCITRAL).

If the parties are unable to settle their dispute amicably, may be submitted for arbitration by a sole arbitrator within 60 days of receipt of the request for an amicable settlement. The procedure is subject to the UNCITRAL Arbitration Rules.

The arbitrator's decision will be final and binding and no appeal to a court or any other jurisdiction shall be allowed.

Given that the UPU is a specialized agency of the United Nations, the place of arbitration will be Geneva and the language English or French.
