# Activities and key principles – alignment with the Global Postal Model

- Terms of reference approved by the POC (April 2024).
- Expert team meetings held monthly, with work carried out between meetings, and risk review conducted.
- Engagement with all modes of surface transport (both directly and via organisations such as the IMO and IRU and via the UPU-Rail Forum).
- Held Webinars including this one to promote the importance and presented with the EC.
- Importance of carrier role emphasized – successful co-working and collaboration will be fundamental.
- High-level requirements and principles aligned:
  - Utilize the framework in place for ICS2 Release 2;
  - Align with the Global Postal Model.
- Pursued a postal technical solution to support Road Carriers in particular. Especially as Postal and commercial flows for carriers have different Master Arrival ENS submissions.





# ICS2 Release 3 is now live for all modes of surface transport

ICS2 R3 has now gone live for all modes of surface carriers and has been rolled out in three steps:

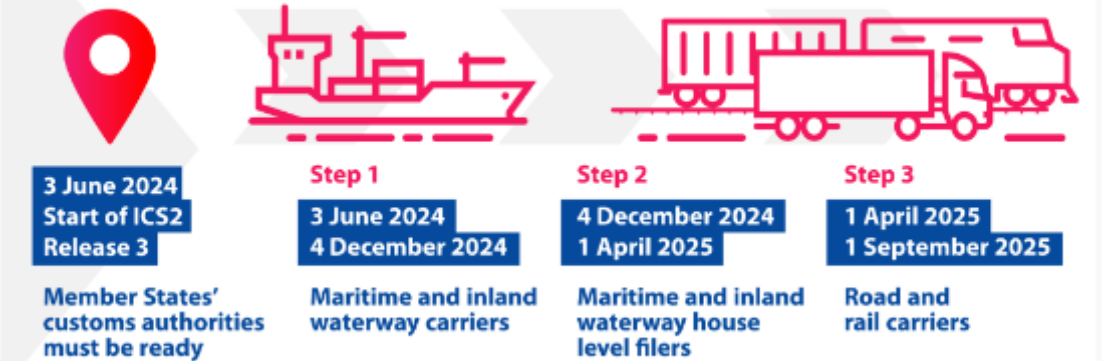
- 1 Maritime carriers from 3 June 2024 to 4 December 2024 (at the latest);
- 2 Maritime house-level filers from 4 December 2024 to 1 April 2025;
- 3 Road and rail carriers from 1 April 2025 to 1 September 2025.

As a reminder, the key dates given by the EC for ICS2 are as follows:

- ICS2 R2 – live in EU member states from 2 October 2023;
- ICS2 R2 – airlines live, with their submissions dependent on the applicable regulation (AR) flag in CARDIT\*;
- ICS2 R3 – ends 1 September 2025.

\* This includes open transit. Enforcement of requirements for closed transit was delayed and did not enter into effect until April 2024. Solutions continue to be explored for transshipment, which were included in the requirements, as well as for more complicated transit flows.

## GET READY FOR ICS2



- There has been some great work by the IPC to extend the air carrier lodgement record to road movements.
- This will help support road carriers in the lodgement of the F40.
- The PTC have also been ensuring IPS and systems are ready for Postal Operators to use.

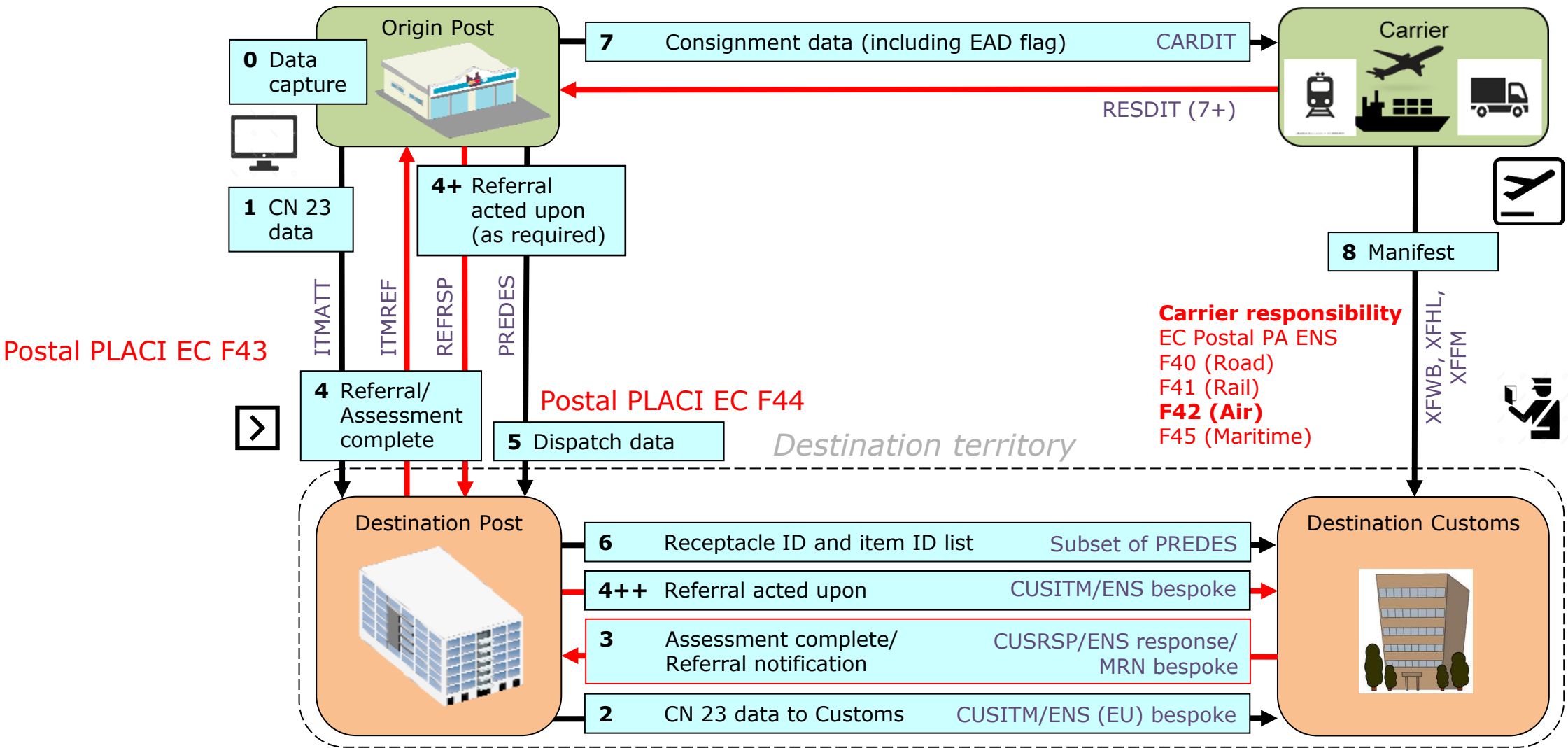


# Global Postal Model flow

# ICS2 requirements: postal model

## CARDIT message

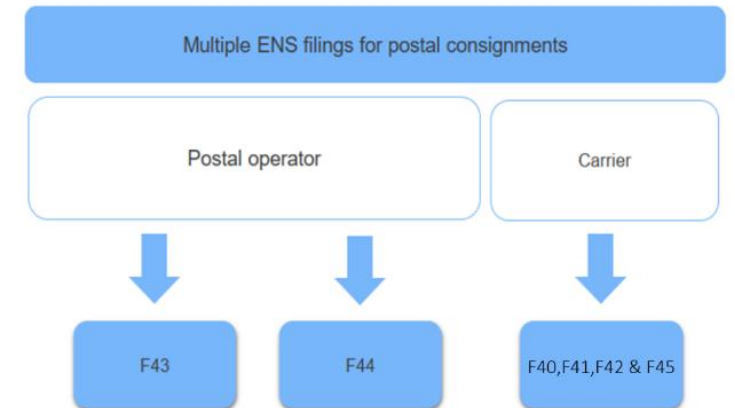
- There is a need to send the CARDIT to all surface carriers;
- IPS can already create CARDIT for surface modes of transport;
- We have asked Posts that use their own systems to create CARDIT and then engage with their respective IT teams.

## Extended code list- Update to UPU standards

- Code list 160 was extended to include surface modes of transport (currently mainly air only);
- It uses international standards where they exist to identify sea and rail transport, but agreement is needed for road transport;
- The new code list was approved by the Standards Board in May 2025.

## Mailboxes

Mailboxes have been built to create the end point for the carriers to collect the message, as was the case for air carriers.

# High level status update

- ICS2 R3 for all modes of transport is live in the “ICS2 Zone” i.e. The EU 27+2.
- Carriers are now lodging the Master Arrival ENS (F40, F41 and F43). They are using information contained within the CARDIT message.
- We are encouraging carriers who have yet to go live to live before the derogation ends. As a number end at the end of the year we are keen to have processes bed in and any queries or issues understood.
- Carriers are using a combination of the Postal IPC system to lodge (and training sessions have been run as well as support) and others, especially those with undertaking the lodgment for air movements are using their own, or provided propriety systems.
- There have been checks by the IB to understand if there was any disruption with flows. The Good news is that there has been no reported issues with release 3.
- There is a planned additional Webinar to have a push to encourage all posts and carriers to be ready and live well before the derogations end.
- We continue to monitor the filings which have been rejected by the use of STOP Words.
- We continued to monitor the timeliness of responses of the end to end systems.
- We will also invoke as requested BCP. Although, keen for improved communication flows in this area.

# European Commission derogation status – by Member States

**What is a derogation:** A derogation refers to a legal provision that allows for an exception or deviation from a general rule or obligation set out in this case, EU legislation.

**What does this mean:** It means in short there was a legal route for the Member States to request a delay in implementing ICS2 R3 (road and rail only).

**Could the European Commission not just apply a blanket extension to time lines:** Whilst this was asked. It was unfortunately not possible. As under the terms set aside it needed to be requested via Member States linked to an exception.

**How did Member States apply for a derogation:** The European Commission wrote to all Member States and gave them two weeks to apply up until Friday 15 August.

The European Commission first published a list of Member States who **had not** requested a derogation.

Then a list of Member States who **were granted** a derogation was issued by the European Commission on the afternoon of the 28 August 2025.

The derogations typically are lasting until the 31/12/25 or the 31/05/25. Details can be located on the EC ICS2 Circ Web Site.

Noting: These apply to all ICS2 R3 movements to those Member States for all modes of conveyance (postal and commercial) and for postal movements the carrier declarant takes place at the first competent authority in the ICS2 area.



# Derogation status reminder

## **Derogations are starting to ending soon**

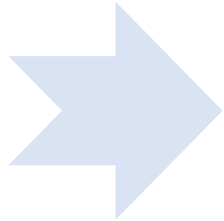
- A number of Member States including France and Ireland will have their derogations lapse on the 01/01/2026;
- This means from this date all road carriers will need to submit the F40 filing to the EC Common Repository;
- Other Member States, such as Poland have derogations that will lapse on the 01/06/2026.

Details can be located on the EC ICS2 Circ Web Site.

**Filing of the master arrival ENS filing especially if using a partners lodgement system, such as the IPC's should be done as soon as possible. Please do not leave it until the last week in December as it will increase the risk of not been completed in a timely manner.**

# Challenges



# Some challenges are expected

Local issues: We are expecting local issues, mainly at the borders between ICS2 countries and non-ICS2 countries for road and rail transport modes. It should be recalled that most postal operators do not have facilities at the border where physical controls could be made. Therefore, unless there is an imminent risk, it is suggested that the security control be carried out at the office of exchange of the transit/destination postal operator.

Contingency plans: IPC and PostEurop have raised the issue of the business continuity plan. There is a need for greater clarity on the implementation process and the EC's communication with economic operators and/or IPC.

Carrier issues: What will happen in cases where carriers and their systems experience delays that are beyond the control of the DO, or if they are not ready on day at the end of the derogation.

Transit: Postal operators consider that they will continue to use the postal transit regime currently in place for road transport modes.

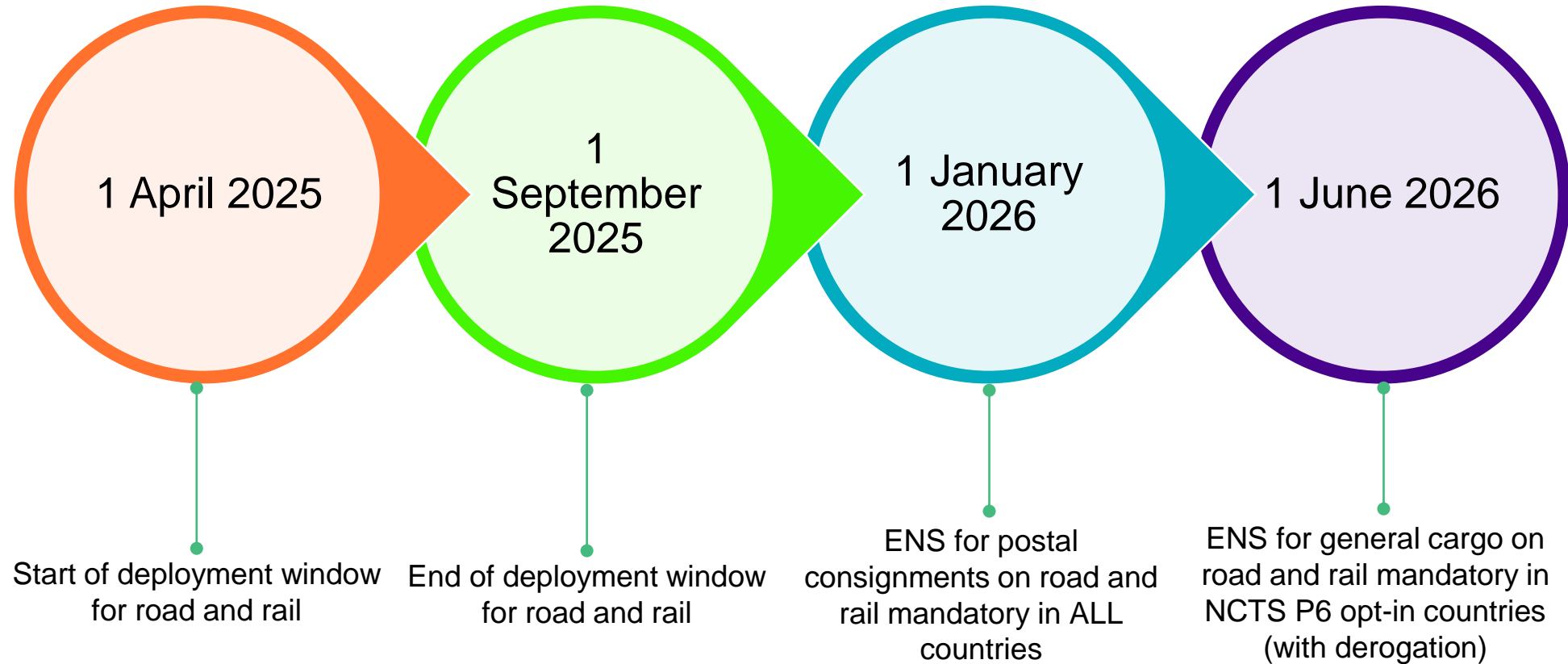

# Requirements to lodge an ENS

- **As of 1 January 2026, filing ENS data in ICS2 for postal consignments arriving by road and rail is mandatory in all countries, irrespective of the derogation granted.**
- Some countries that implemented NCTS P6 (opt-in) allow to lodge a transit declaration with ENS data and they will have a derogation until 1 June 2026. However, transit declaration with ENS data cannot be used for postal consignments. Only general cargo (e.g. ETOE consignments) could benefit from this arrangement.

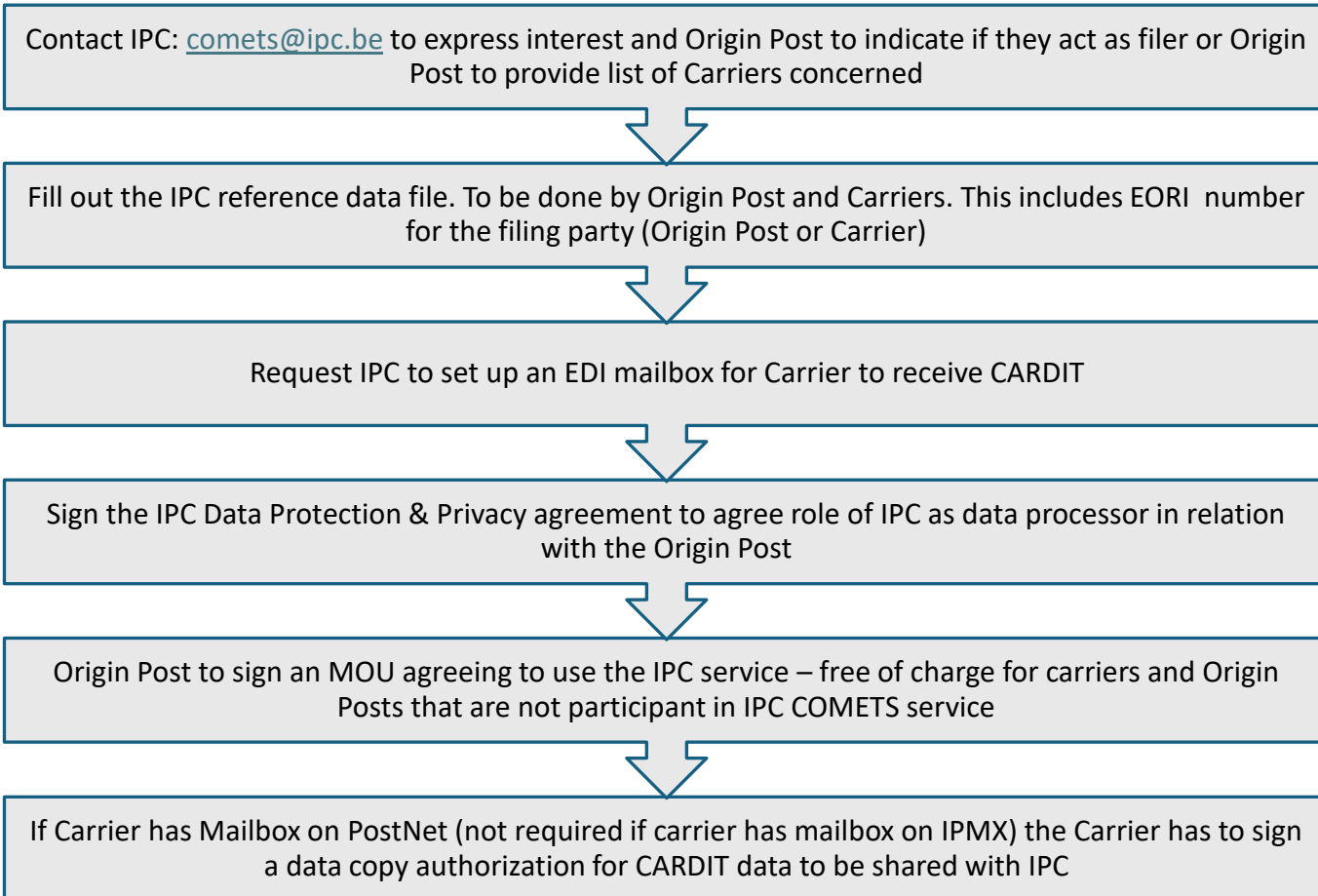

# ICS2 Release 3 – what to do to access IPC COMETS filing solution

## Pre-requisites to be in place to start

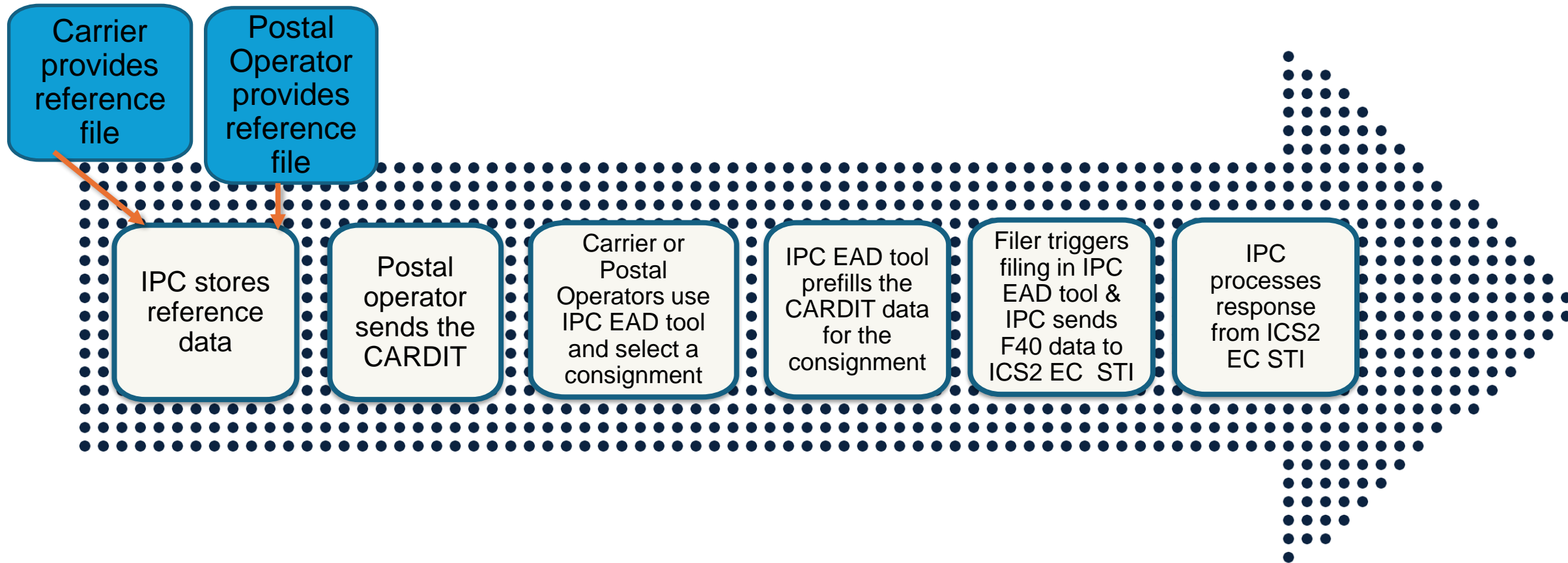


- Currently 10 posts set up, several of which act as declarant in relation with all carriers concerned and in addition IPC set up 15 carriers as declarant in relation with posts
- The IPC ICS2 R3 F40 filing solution has been deployed end of August 2025
- Due to derogation only limited use to date
- IPC encourages parties to run end-to-end test in Production a.s.a.p. and well before X-mas holiday period

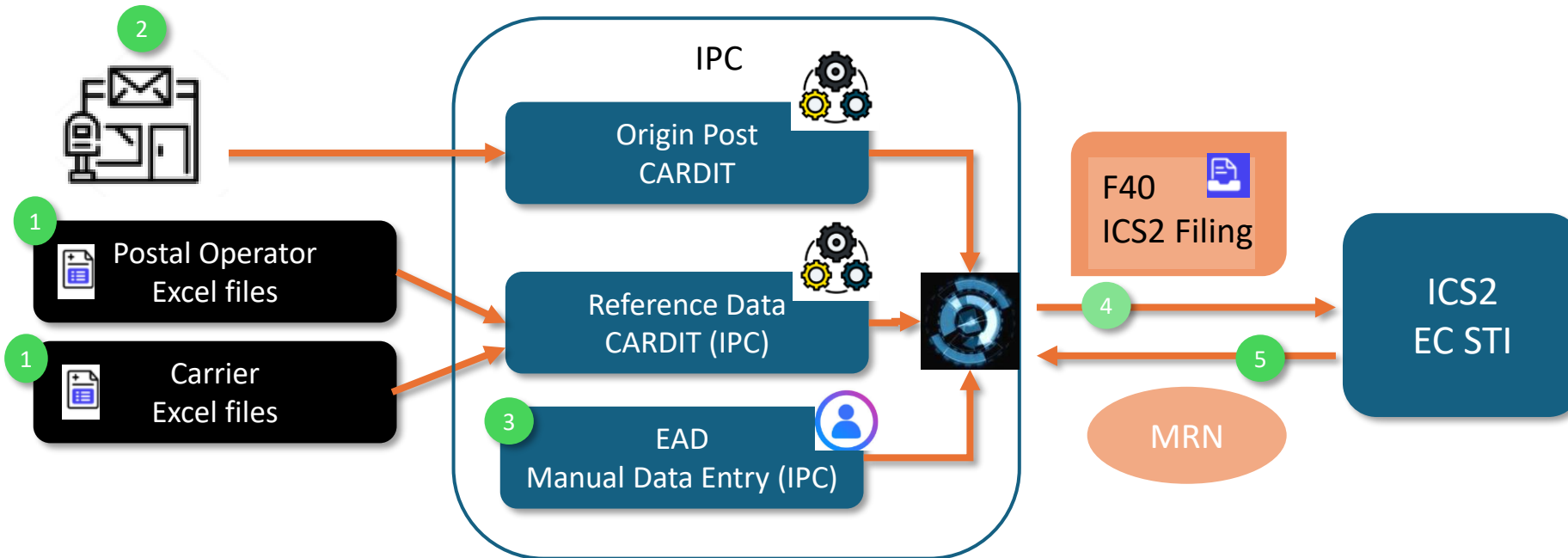




# IPC COMETS - ICS2 Release 3 F40 filing Solution – e2e process



# IPC COMETS - ICS2 Release 3 F40 filing Solution – data flow



- 1 Postal Operator & Road Carrier provides the reference data (One Off Operation)
- 2 Postal Operator sends CARDIT for Road (IATA code or UNLOCODE)
- 3 Postal Operator or Carriers searches and selects a CARDIT & manually enters the remaining data in the IPC EAD tool
- 4 IPC EAD tool sends ICS2 F40 (road) filing to the EC standard trader Interface
- 5 EC standard trader Interface sends the MRN back to the Carrier/Postal Operator

# EDI configuration in IPS

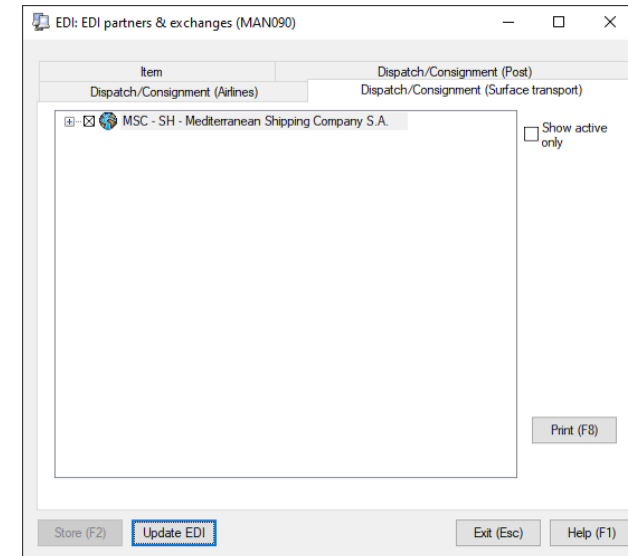
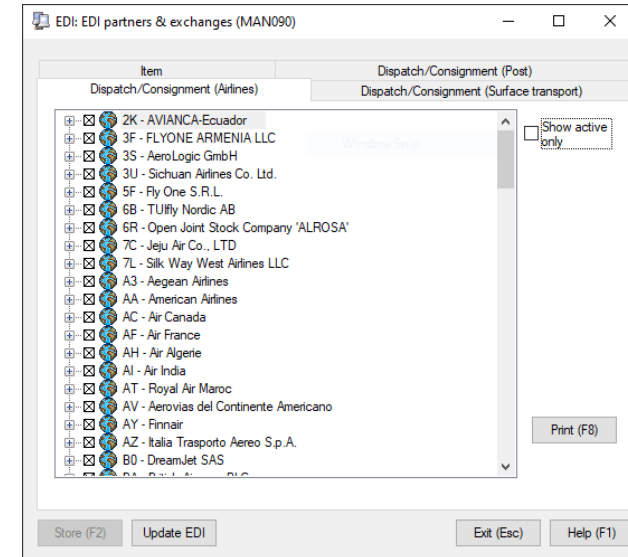
From IPS 2023 SP1, the application can be configured to send **CARDIT** and receive **RESBIT** with all types of carrier:

- Air
- Maritime
- Rail
- Road



The list of **airlines** is automatically updated with the **IPS reference data** (Source: IATA)

The list of **surface transport companies** must be manually maintained until automatic update will be implemented in a future IPS release

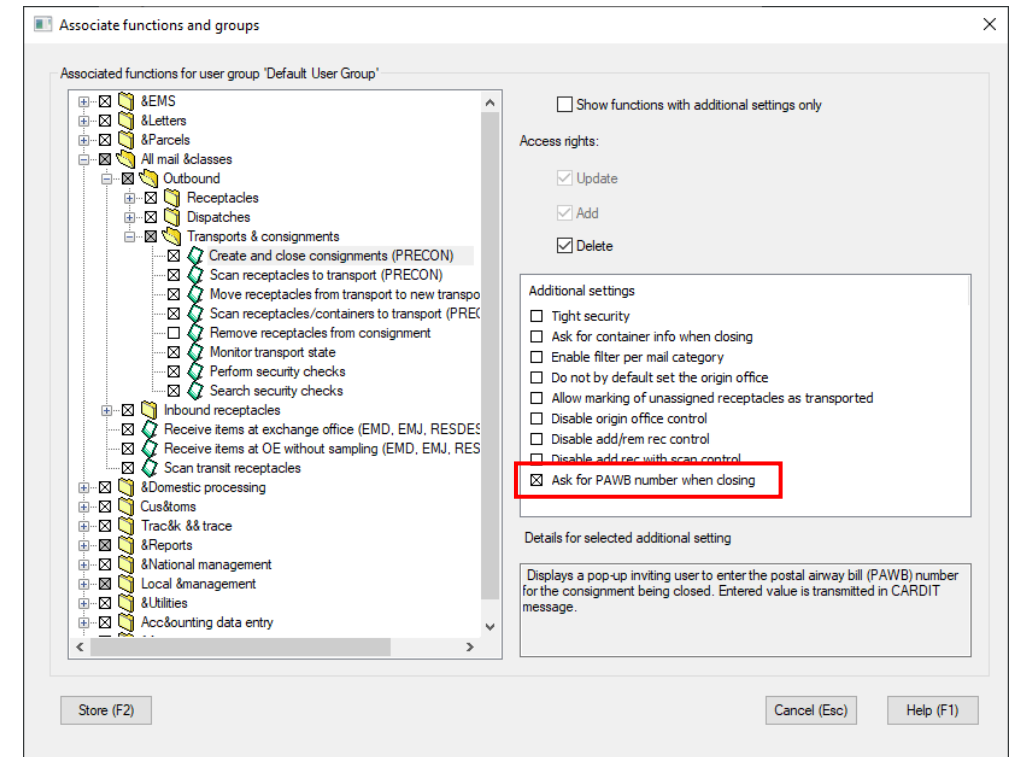

# Postal Airway Bill (PAWB) Bill of Lading (BoL)

**IPS can be configured to capture a PAWB or BoL at the consignment closure**

1. Run the *Local management > System > Users & workstations* function
2. Click 'User groups' tab
3. Select the user group of the staff responsible for closing consignments
4. Click the 'Associate...' button
5. Select 'All mail classes > Outbound > Transport & consignments > Create and close consignment'
6. Tick the 'Ask for PAWB number when closing' checkbox
7. Click the 'Store (F2)' button
8. Restart IPS

The UPU is studying the possibility to dynamically get the PAWB from carriers



# Support for IPS versions prior to 2023 SP1

A workaround is available for Posts running IPS 2023 base or earlier

Surface transport companies can be created as airlines, and then used in surface routes

Limitation: the generated CARDIT messages will indicate *mode-of-transport* as '4' (air)

- But surface carriers may find the limitation acceptable
- IPC confirmed that they can do the ENS filing for surface carriers with such CARDITs

Post needing to implement this workaround should contact PTC support to obtain the tools and instructions to put it in place

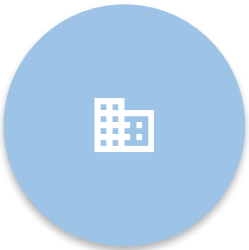

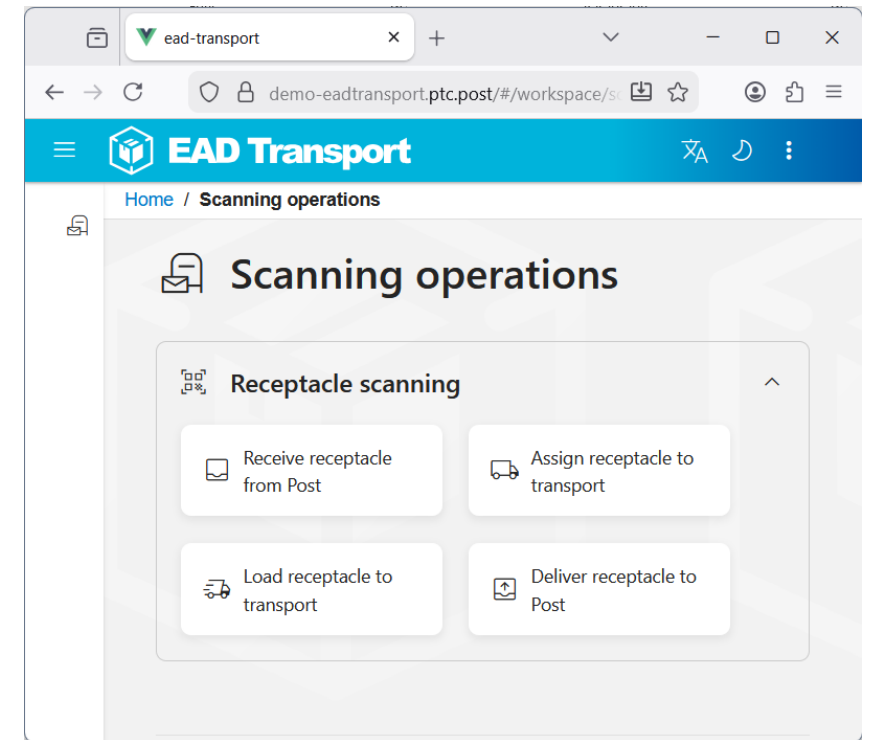

# EDI address on POST\*Net



- Any carrier can request the creation of an EDI address on POST\*Net
- Simple procedure that only requires signing a license agreement
- Included in the POST\*Net fees: QCS reports and dashboards for monitoring the EDI transmissions, alerting mechanism in case there is no EDI transmission for a certain period, or if CARDIT messages have not been downloaded



- Designated operators acting as carriers can request an EDI address at no additional cost beyond EDI transmission fees.

# Collaboration with MSC on EDI Exchange (2024–2025)



- Initiated communication with MSC on EDI exchange in mid-2024
- MSC actions:
  - Opened EDI mailbox in PNET for CARDIT/RESKIT exchange
  - Requested Bill of Lading (BoL) in CARDIT 47
  - Updated IT system to import CARDIT 47 and generate F45 using CARDIT data + BoL
- Successful test: CARDIT test message led to correct F45 generation by MSC
- PTC confirmed IPS 2023 SP1 is required to include BoL in CARDIT
- IPS 2023 SP1 provided to Australian Post for upgrade IPS 2023
- Australian Post implemented required changes and sent first CARDIT in production to MSC– May 2025
- Container successfully handed over via MSC to the EU with new F45 message





# High level overview – Operations for Sea Mail to EU



## Sea Mail data flow:

- When we book a container, MSC provides us with a Sea Waybill number
- When closing a sea mail consignment in IPS, the user will enter the Sea Waybill number, along with other requested information as needed
- IPS will then generate the CARDIT message with the Sea Waybill details.

## Current operations and issues:

- The main issue is untrained team members forgetting to capture the waybill when closing consignments
  - MSC notifies us of the missing data
  - In that case the consignment must be re-opened and re-closed with the data then correctly filled in, which can be days after departure
- No issue reported by MSC or EU Posts so far

# Preparation of operations for ICS2



26 February 2025 – Meeting with representatives of Croatian Post regarding the implementation of ICS2 in road transport.

28 February 2025 – The Post of Serbia obtained its EORI number.

March–June 2025 – Negotiations with Croatian Post, agreed the Šid/Tovarnik border crossing would be used. We contacted customs and border police to prepare conditions for our vehicle to cross the border with minimal waiting time; HP did the same.

July 2025

Our customs authorities and border police granted approval for exchange through this border crossing.

## IT solutions for filing of required messages and communication with carriers



30 June 2025 – Information about the Post of Serbia, in its capacity as postal operator and carrier, was sent to IPC COMETS.

July 2025 - A Memorandum of Understanding was signed between IPC and the Postal Operator and IPC COMETS ICS2. The process for implementing the new IPS 2024 version, which supports data exchange with the EAD application, was initiated.

August–October 2025 - Tests were conducted for sending CARDIT messages and forming consignments in the EAD application

September 2025 – facing the fact of Croatian authorities require submission of forwarder's electronic pre-announcement messages for all consignments containing goods. Additional cost for us.

## **Implementation phase, concerns, way forward (successful implementation or changing transport mode / unsuccessful implementation->> pending challenges).**



Early August 2025 – It became clear that IT conditions for ICS2 R3 implementation could not be met. On 11 August, notifications were sent to neighbouring countries (HU, BG, HR) that surface exchange was being discontinued and dispatch would be shifted to air transport.

Hungary (from 1 September) and Bulgaria (from 18 August) – Regular national air carrier routes were established and transport quality was maintained.

From 1 September 2025 – Dispatch to Croatian Post possible only via Lufthansa. Quality was significantly reduced and the cost more than doubled. The number of complaints increased.

From 26 October 2025 – Dispatch carried out only **twice a week by air to Vienna, then by truck from Vienna via Ljubljana to Zagreb**. An increase in complaints is expected.

**NOTE:** The national air carrier, Air Serbia, has been unable to establish cooperation with Croatian customs and airport authorities. Since February 2025, we have been in communication with them, hoping for progress and the eventual establishment of postal dispatch.

  - Postal operator as a road carrier
  - Country of first entry and EORI number
  - Implementation window
- Close cooperation with Croatian Post
- Communication with UPU, PostEurop and IPC
- Communication with other non-ICS2 operators

# ICS2 R3 – Challenges

- Filing F40 as a road carrier
- IE3G301 message required
- ICS1 filings required after 01.04.2025
- How to submit data required by customs?
  - Freight forwarders
  - IPC
- Priority when crossing the border
- Search for alternative routes

## ICS2 R3 – Implementation

- Two derogations (01.10.2025 and 31.12.2025)
- IPC's solution for F40 filing tested and ready
- Freight forwarders confirmed their compliance (IE3G301)
- Air carrier also ready
- Costs, speed and reliability concerns
- Final decision is expected early December at the latest

## ICS2 R3 – Lessons learned

- Early assessment and impact on operations
- Communication and cooperation
- Software solution for F40 filing developed within postal sector
- Backup solution
- Support from UPU, IPC, PostEurop and partner operators

# Operational Preparation for ICS2 R3

- Maintaining close collaboration with railway partners to develop tailored postal rail solutions.
- Established regular communication with the ICS2 team at Polish Customs.
- Identified a potential rail agent capable of handling ENS filings for postal shipments by rail.
- Secured a derogation from Polish Customs for ICS2 R3 until 31 May 2026.
- Mail-by-rail flows from China into Europe remain stable and uninterrupted.

# Data Submission and Filing Process for Mail-by-rail

- The rail agent confirms that China Post can submit CN37 and pre-advice documentation via email, with no system integration required.
- The rail agent has specified data requirements for F41 filing.
- China Post will provide the necessary data; **the rail agent will manage the conversion and ENS filing for F41.**

- **container number**
- **SMGS waybill number**
- **recipient**
- **shipper**
- **loading place**
- **unloading place**



# Challenges and Next Steps

- **Operational Risk:** Manual ENS filing by the rail agents remains prone to human error.
- **Our Action:** Actively pursuing system-to-system integration with agents.
- **Our Request:** Clear operational guidelines for the rail agents from Polish Customs to standardize the filing process for postal shipments.
- **China Post is committed to ensuring seamless and fully compliant rail transport operations, both during the derogation period and beyond.**
